- 3. President's Report of 2022
 - A. Board Report of 2022
 - i. Assessments received from 170 homeowners: 1 payment outstanding at time of meeting (Mike) *Outstanding payment subsequently received.*
 - Mike reviewed the 2022 expenditures to date, projections for end of year. Presented and discussed the 2023 budget, approved by homeowner ballot.
 - ii. Maintenance repairs at Lindberg entrance (Mark)
 - Sprinkler system repaired and activated
 - Contracted for masonry repairs to monument walls
 - Upkeep and maintenance of beautiful landscaping on both sides of entrance
